- Identify and respond appropriately to safeguarding and student wellbeing concerns, in accordance with school policies and applicable regulations.
- Support routine medical examinations, health screenings, and preventive health initiatives for students.

- Maintain accurate, up-to-date, and confidential medical records and student health files in compliance with school policies, safeguarding standards, and data protection regulations.
- Coordinate with local health authorities to implement public health measures in line with community and national guidelines.
